

MINUTES OF THE REGULAR MEETING OF THE TUSCOLA TOWNSHIP
BOARD HELD ON TUESDAY,
AUGUST 17, 2004, AT 7:00 P.M.

The meeting was called to order by the Supervisor, Tod Fackler, at 7:00 P.M.

Roll Call – Present: Olson, Hohman, Fackler, Bushong and Blasius.

Additions to the agenda include F. Township Ordinance Violation Form and G. Tuscola County Road Commission.

Bushong corrected the minutes of the July meeting which changed the word if to is in the third paragraph from the bottom. Hohman made a motion to approve the minutes of the July meeting with the correction and this motion was seconded by Bushong. Carried.

Bushong read the minutes of the Planning Commission.

Fackler reported that the Board of Appeals will meet on September 15, 2004, at 7:00 P.M. which is a meeting requested by Blasius, Inc.

Hohman reported that the VAAS is planning some repair work to the ambulance base parking lot.

Fackler stated that the minutes of the VAAS, Bullard Sanford Library and Sheriff's Report is on file for review. The TCED annual report and projected 7-1-04 to 6-30-05 has been received.

Schmandt distributed the zoning report. Fackler made a motion to send the violation of Karl and Linda Eastman to the attorney and this motion was seconded by Bushong. Carried.

Fackler made a motion to approve the Metro Act for SBC and this motion was seconded by Bushong. Carried.

A request for a deaf child sign was submitted for property at 6709 S. Vassar Rd. Blasius made a motion to approve this sign and this motion was seconded by Hohman. Carried.

Blasius, Inc. submitted a request for approval of an Industrial Development District and an application for Industrial Facilities Tax Exemption Certificate. Fackler made a motion to hold the public hearings prior to the regular meeting of September 20, 2004. The public hearing for the Industrial Development District will be held at 6:30 P.M. on September 20, 2004 and the public hearing for the Industrial Facilities Tax Exemption will be held at 6:45 P.M. on September 20, 2004. This motion was seconded by Bushong. Carried.

The regular meeting date of the meeting has been changed to September 20, 2004, because of scheduling conflicts.

Bushong made a motion to have 15 copies of the zoning ordinance book copied. This motion was seconded by Olson. Carried.

A Tuscola Township Ordinance Violation form was distributed and discussion ensued. This form will be reviewed and brought back to the township board with additional revisions.

Fackler reported that the T.C.R.C. will be replacing a tube crossing Buell Rd. at a cost of \$2,000 to the township. Fackler made a motion to approve the replacing of this tube and this motion was seconded by Hohman. Carried

Bushong inquired about the progress of the resolution adopting a schedule of costs for a hazardous materials incident. MTA will be contacted for advice .

Bushong also stated that cemetery information is now located on the township web site.

Fackler made a motion to approve the clerk , Mary Lou Blasius, Trustee, David Bushong and Sexton, Cyril Haines to meet for the purpose of updating cemetery records and putting information on computer. This motion was seconded by Olson. Carried.

Bushong read a personal letter regarding the past eight years of progress in Tuscola Township.

Bills were submitted in the amount of \$23,992.09. Olson made a motion to accept these bills for payment and this motion was seconded by Bushong. Roll call vote: yes-Hohman, Bushong, Olson, Blasius and Fackler.

Fackler made a motion to change the September meeting to September 20, 2004, the October meeting to October 18, 2004, and the November meeting to November 8, 2004. This motion was seconded by Blasius. Carried.

This meeting was adjourned at 8:40 P.M.
