

**MINUTES OF THE TUSCOLA TOWNSHIP BOARD HELD ON TUESDAY,
JUNE 17, 2008, AT 7:00 P.M.**

The meeting was brought to order by the Supervisor, Tod Fackler, at 7:00 P.M.

Roll call: Present-Fackler, Bishop, Olson and Blasius. Absent-Bergdolt

Fackler requested that a and h under new business be placed at the beginning of the meeting. A motion was made by Blasius and seconded by Olson to approve the agenda with these changes. Carried.

Olson made a motion to approve the minutes of the May meeting and this motion was seconded by Bishop. Carried.

Fackler read the minutes of the Planning Commission.

Bishop gave a verbal report on the activities of the Parks and Recreation board. The basketball hoops have been installed and plans are underway for a sand volley ball court and horseshoe pits.

Larry Clever from Burnham and Flower was present. He reviewed the township's insurance policy and answered all questions.

Fackler reported that the minutes of the VAAS are on file.

Fackler reported that there will be a closing very soon for the property on Church St.

Schmandt submitted his blight list for June. New pictures were viewed for Barnum, Wheeler, Carney and Gohsman. These violations will be clearly marked or circled to prevent any misunderstanding.

Blasius reported that the electric door opener for the hall is in process. This should be installed very soon.

Fackler submitted a 2007 Financial Report for the Tuscola County Road Commission and reported on his meeting with the commissioners and supervisors.

Fackler reported that the Tuscola County Drain Commission will be spraying the Ash Branch of the Sheboygan drain that will cover Sections 4, 9, and 16.

The Tuscola County Board of Commissioner's April activity report was distributed.

On July 22, 2008, a MTA Workshop concerning Special Assessments and Ordinance Enforcement will be held in Frankenmuth.

Fackler reported on his meeting with the Richville Community Fire Association. Fackler is working on a program to ensure that Denmark Twp. will be a viable participant in this association.

Fackler reported that he has requested Advance Surveying to survey the West line of the Township property on both sides of VanCleve Road.

Blasius made a motion to raise the salaries of each chair of the township boards to be the same as the secretaries effective 7-1-08. This motion was seconded by Bishop. Carried.

Fackler will request Worth Construction to submit a bid for removal of stumps and burning of debris on the township property located at VanCleve Road.

Bills were presented in the amount of \$107,317.42. It was moved by Olson and seconded by Blasius to accept these bills for payment. Roll call: Yes-Olson, Fackler, Blasius and Bishop.

The meeting was adjourned at 9:15 P.M.
