

**APPROVED MINUTES OF THE REGULAR MEETING OF THE TUSCOLA TOWNSHIP BOARD HELD
ON TUESDAY, JANUARY 17, 2012, AT 7:00 P.M.**

The meeting was called to order by the Supervisor, Tod Fackler, at 7:00 p.m.

Roll call: Present-Bushong, Fackler, Olson, Bishop and Blasius.

Fackler added terrorism risk insurance to the agenda before item 8-f.

Bushong made a motion to approve the December, 2011, minutes and this motion was seconded by Olson. Carried.

Lori Warmbier was present to inquire about the blight notice she had received regarding an automobile that was not registered. She stated that she had two or three tabs stolen from her automobile and had not put the last tab on. The car is no longer there so the issue has been corrected.

Bishop reported that the Planning Commission did not meet in January.

Bushong reported that the Public Hearing for the new Park and Recreation Master Plan was held on January 9, 2012. The township board will receive a resolution to approve the plan soon. He also stated that the Tuscola Township Park & Recreation Board will have a budget hearing on February 7, 2012.

The Zoning Administrator, Dennis Schmandt, distributed the blight list for January and the final 2011 zoning permits.

Fackler reported that the township attorney is presently drafting the new Frankenmuth Fire Agreement.

Fackler submitted a bill for \$1655.00 from Sewah Studios for signage with regard to the Cass River Greenway project.

After some discussion concerning the Construction Code Group, Fackler will contact Lohrstorfer with some questions and concerns that have surfaced recently.

Fackler stated that the FEMA maps have been received.

Bushong made a motion to reimburse Robert McKay for garbage and ambulance fees for 2010 and 2011 for the home that he owns on Day Rd. and is currently vacant. This motion was seconded by Blasius.

Fackler will be contacting Kurt Damrow's office for a date that he can meet with the township board.

Fackler made a motion to appoint Earl Begg for a one year term to the Board of Review and this motion was seconded by Blasius. Carried.

The Tuscola Township Budget Workshop will be February 13, 2012, at 7:00 p.m.

Bushong made a motion to decline the terrorism risk coverage offered by Burnham and Flowers and this motion was seconded by Bishop. Carried.

The budget will be amended at the next meeting.

Bills were presented in the amount of \$77,596.95. It was moved by Olson and seconded by Blasius to accept these bills for payment. Roll call: Yes-Olson, Fackler, Bishop, Blasius and Bushong.

This meeting was adjourned at 8:45 p.m.
