

APPROVED MINUTES OF THE TUSCOLA TOWNSHIP BOARD HELD ON TUESDAY, FEBRUARY 21, 2012, AT 7:00 P.M.

The meeting was called to order by the Supervisor, Tod Fackler, at 7:00 p.m.

Roll call: Present-Bushong, Fackler, Bishop, Olson and Blasius.

Fackler moved item a. under new business, Curtis Stowe from SCMCCI, to after the minutes and before public comment. Item c. under unfinished business was deleted.

Bushong made a motion to approve the minutes of the January meeting and this motion was seconded by Olson. Carried.

Curtis Stowe, building official from SCMCCI, was present and gave a presentation concerning the services that they are providing to the township and that they are willing to continue to provide.

The Planning Commission minutes from the December 7, 2011, meeting were distributed as well as the Planning Commission year end review for 2011.

Fackler stated that the Board of Appeals will meet on March 21, 2012.

Bushong stated that the next Parks and Recreation meeting will be March 6, 2012.

Schmandt distributed the blight list for February.

Fackler reported that the February 19, 2012, minutes for the VAAS will be placed on file for review.

Fackler stated that the fire contract with Frankenmuth has been completed and will be addressed at the March meeting after the board has an opportunity to review it.

Fackler reported that Republic will be donating a dumpster to be used for the river clean-up day.

Fackler stated that FEMA has set April 3rd as a deadline to have an ordinance and resolution completed with regard to floodplain management measures. They will send sample resolutions and this will be addressed at the March, 2012, meeting.

The 2012 county tire collection agreement will be tabled until the March meeting.

Fackler presented a request from the T.C.R.C. concerning a .06 mile portion of Van Buren Rd that belongs to Denmark Township. They asked if our township would consider taking the

stub into our local system. After some discussion, it was the consensus that we would not be interested in spending township monies for a road belonging to another township.

After discussion concerning current zoning permit and land division fees, a motion to increase the Zoning Permit Fees to \$30 for residence and \$60 for commercial was made by Bushong and seconded by Bishop, effective April 1, 2012. Carried.

Fackler will determine if our ordinance allows for a Land Division fee and this will be addressed at a future date.

Bills were presented in the amount of \$11,862.57. It was moved by Olson and seconded by Blasius to accept these bills for payment. Roll call: Yes-Bishop, Bushong, Olson, Blasius and Fackler.

The 2012-2013 Budget Hearing will be held on Tuesday, March 20, 2012, at 6:30 p.m.

This meeting was adjourned at 8:45 p.m.
